**ROTARY CLUB OF NASHUA 2018 COMMUNITY  
GRANTS AVAILABLE**

***All application materials must be RECEIVED BY 4:00 pm on May 11, 2018.***

The Rotary Club of Nashua is committed to "Service Above Self" and is dedicated to making the Nashua Community a better place. The Club holds a number of fund raisers throughout the year and 100% of all profits go back to the community in the form of scholarships and community grants. The Rotary Club of Nashua Community Grants Program is administered by the volunteer members of the Club to benefit the non-profit community in Nashua, New Hampshire.

In 2018, a total of \$25,000 will be awarded in community grants to non-profits serving the Nashua Community. The awards granted will be in the range of \$1,500 - \$5,000. Therefore, the Nashua Community Program/Project must be in that range.

Although any non-profit may apply, preference is given to those non-profits that impact the greatest number of Nashua citizens. Requests for general agency operating funding will be considered a low priority. The Rotary club of Nashua does not honor requests for on-going multi-year funding.

Please do not lobby members on your behalf. Decisions will be based solely on this application and community

needs along with available grant funds.

## **Eligibility**

Applicants to the Rotary Club of Nashua Community Grants Program must meet the following eligibility criteria:

- Non-profit must be focused on serving the needs of the Nashua Community and its citizens.
- The Nashua Community Program/ Project must be in the range of \$1,500 - \$5,000.
- All applications must be complete and include the required financials.
- Willing to participate in an interview.
- **Non-Profit that received Nashua Rotary Community Grants funding in 2017 is NOT eligible to apply in 2018.**

## **Process**

Completion of the Rotary Club of Nashua Community Grant Application is required, A small number of finalists may be invited for a face-to-face interview with the Community Grants Committee. Award recipients will be notified in May and will be invited to attend a Rotary luncheon meeting on June 18, 2018 to accept the grant award.

1. Form 990
2. Operating Budget for the current fiscal year.
3. Your organization's non-profit status, Please attach

4. If you are in the process of applying for your non-profit status, please include the organization that will be your fiscal agent.
